³ "We moved from [Hope] Arkansas in 1908 to Idabel, Oklahoma and farmed two years. Papa bought 40 acres of land north of Valliant at a post office settlement called Slim, Oklahoma. We moved into our new home in 1910". Told by Dora SCAGGS Moye, Isabel's sister, at age 87.

⁴ There is an O.A. Simmons (1870-1933) buried near Elias Scaggs in Pollard Baptist Church Ceme./ Idabel, McCurtain Co., OK. Isabel's sister Paralee b.1886 was married to a Simmons called Lon or Lund - possibly a nickname, but Mom remembers him as being Paralee's age.
